2. Sealed quotations are invited for the disposal/Auction of the aforesaid vehicle on the terms and conditions mentioned below. Interested parties may submit their quotations in the enclosed Performa. The sealed quotations must be addressed to the Principal, Sainik school Kazhakootam, which should be dropped in the Tender box at the Reception, Sainik school Kazhakootam. Or may be sent Regd post to Principal, Sainik school Kazhakootam, Kazhakootam Post, Trivandrum -695585 by 3 PM on 30 Apr 2026. The quotations received in time will be opened at 3.30 PM on the same day (ie, 30 Apr 2026). The cover should be prominently super subscribed with the words "BID FOR THE AUCTION OF SCHOOL BUS".

3. The quotations received in time will be opened in Mini Conference Hall, Sainik School Kazhakootam. The bidders or their representative (Not more than one) may be present, If they so desire at the time of opening of quotations:

4. The sale will be governed by the following conditions:

(i) This bidder required to pay **Earnest Money Deposit (EMD)** of **Rs 10,000/- (Rupees ten thousand only)** for the vehicle.

(ii) Earnest money is payable by means of Demand Draft in favour of Prncipal Sainik school, or through online payment in favour of A/C No 1368606153

(iii) Bids received without receipt of EMD payment will not be considered and shall not be accepted. The EMD of the successful bidder will be released only after completion of all formalities for the sale of the vehicle. EMD will not be adjusted as sale value and be forfeited if he fails to honour the bid. EMD of the unsuccessful bidders will be refunded within 05 working days.

(iv) The successful bidder will be required to deposit 50 percentage of bid amount immediately on acceptance of bid and balance amount within 5 working days of the acceptance of the bid.

(v) The delivery of the sold vehicle will be arranged only after transfer of the vehicle on the successful bidders name and submission of documentary evidence in support of the same.

(vi) The sold vehicle will be removed by the successful bidder within 3 days of depositing the money and relevant documents and at their own expenses.

(vii) The vehicle will be disposed off on "as is where is basis" and no guarantee for its worthiness or quality will be given by this school.

(viii) The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his/her name at their own cost expeditiously.

(ix) The Bids must be submitted in the prescribed Performa only otherwise would be rejected.

(x) Principal Sainik Schol, Kazhakotam reserves all rights to accept or reject any/all the Bid without assigning any reason.

5. The auction proceedings will be carried out as per the following system:

(i) Those who have deposited the EMD money only be permitted to participate in the auction.

(ii) Open public auction will be carried out based on the base price fixed for the bus by the school.

(iii) After arriving a final auction amount, the sealed quotations received for the bid will be opened in the presence of all participants.

(iv) The highest amount quoted out of sealed tender/open public auction will be finalised for awarding bid.
